**Relevance:**

Exploring the history of the Kazakh language, we rely on the language of written monuments of the Middle Ages. The subject of our research is lexemes, set expressions, phraseological units and proverbs in the language of written monuments of the Middle Ages. The analysis of spiritual and cultural values, the study of them as a national linguistic picture of the world, the determination of their ethnocultural character seems to be a very important problem for us. Undoubtedly, it is important to study the national worldview and culture, the system of thinking of an ethnic group, based on the language of the nation, in order to balance the culture formed through language.

**The aim:**

The main aim of the study is to research the linguistic picture of the world, cultural and national values by comparing the language of Kipchak written monuments with the vocabulary of the Kazakh language as an entire lexical system, based on the main process of a comprehensive study of written monuments in the philological science of foreign and national Turkologists

**Expected results:**

- for 2023:

A comprehensive analysis of studies of medieval written monuments will be carried out. A list of scientific literature on the theme of research will be compiled;

There will be collected and analyzed texts of written monuments; the vocabulary was differentiated and Turkic words were identified; The theoretical aspects of studying the linguistic picture of the world are considered;

A lexical and semantic analysis of Kipchak written monuments of the Middle Ages will be carried out;

The vocabulary of written monuments in the systems “Man”, “Society”, “Nature” and within their microsystems will be defined and analyzed;

- for 2024:

Kipchak will be determined, i.e. Kazakh level of the linguistic picture of the world of spiritual and cultural values, reflected in the language of written monuments of the Middle Ages;

By comparing the linguistic data of written monuments of the Middle Ages with the Kazakh language from an ethnocultural point of view, the continuity of the language and a common worldview will be revealed;

The existing linguistic picture of the world in the historical consciousness of modern Kipchak peoples and ancient Kipchaks will be analyzed;

National uniqueness in the name of each word that defines the essence of a historical and cultural phenomenon will be determined, and the nomination limit will be identified;

Based on the results of the implementation of the scientific project, 2 (two) scientific articles will be published in a peer-reviewed foreign or domestic publication recommended by the Committee for Education and Science of the Ministry of Education and Science of the Republic of Kazakhstan;

As a result of the project, a scientific booklet will be published describing the linguistic picture of the world of Kipchak written monuments;

- for 2025:

The continuity of the ancient Kipchak character and the national (Kazakh) character of the linguistic picture of the world will be revealed through the lexical system of the language, formed over the centuries;

The image of the national material and spiritual culture of everyday vocabulary in the language of written monuments of the Middle Ages will be analyzed;

Written monuments on the topic of religious education and their spiritual and cultural relationship with traditional Islam of Kazakh society will be analyzed;

The continuity and cumulative function of worldview and thinking will be shown. As a result of the study, the idea of “Spiritual Revival” will be revealed in terms of content and national spiritual values will be promoted. The linguistic picture of the world of spiritual and cultural values in the language of the written heritage of the Middle Ages is preserved at the Kipchak, that is, Kazakh level;

One (1) article will be published in a peer-reviewed scientific publication, indexed in the Web of Science database and (or) having a CiteScore percentile in the Scopus database of at least 35 (thirty-five);

The research results will also be published in collections of international and domestic conferences and round tables and seminars will be held.

Based on the results of the research, a scientific monograph on the research topic will be published.
